DEFINITION

Hydro-alcoholic mixture made of emulsifying detergents and sub-micronic mineral particles.

DESTINATION AND PERFORMANCE

BEL GRES is a specific detergent formulation for the frequent cleaning of PORCELAIN TILES, both natural matt and polished. Its regular use keeps the surfaces clean and ungreased. Its micro-dispersed mineral component helps to keep the protection and shine of polished and lapped tiles. Does not leave clouds nor dulling, thanks to its special formulation without resins and to the presence of highly-soluble and high-stability surfactants.

DIRECTIONS FOR USE

For the frequent and ordinary cleaning: dilute BEL GRES at 2-3% with clean water (approx. half glass in 5 litres), pour onto the surface, rub with a mop and remove with a micro-fibre cloth. Rinsing is not necessary.

For heavy-duty and extra-ordinary cleaning: use BEL GRES pure or diluted with water (max 50%). Rub with a medium-hard abrasive pad (for rough surfaces) or with a soft pad (for polished and matt surfaces). Remove the residue and rinse with clean water.
