#### **DEFINITION**

Solution of strong alkali, surfactants, and emulsifying agents with high degreasing power.

#### **USE AND PERFORMANCES**

**SGRASSATORE** rapidly eliminates residues and deposits of organic dirt and substances of oily and greasy nature of vegetable, animal, or mineral origin. Ideal for the cleaning of floor and covering surfaces, and kitchen, food processing, and mechanical workshop counters. It forms a homogeneous and persistent foam that acts for a long time, also on vertical surfaces. If used as indicated it does not damage metals, chromium plating, and plastic. Avoid contact with wood surfaces, since the alkalinity of the product can cause formation of stain and dark rims due to the reaction with the tannins.

#### **USE MODALITY**

Open the valve and spray the product on the surface to be cleaned. Let act for a few seconds, rub the surface with soft abrasive sponge and rinse repeatedly with clean water, better if hot. Repeat if necessary. Avoid prolonged action on metals and plastic. Do not apply on wood surfaces.

Indicative consumption: according to the type and consistency of dirt to be removed.
