Solution of controlled action organic and inorganic acids, complexing agents and surfactant foaming agents.


USE AND PERFORMANCES

DECALCARIZZANTE rapidly eliminates residues and limescale. The formula with specific additives allows obtaining, during the application, a homogeneous and persistent foam that acts for a long time. Therefore, it is ideal for cleaning vertical surfaces. It does not release fumes, does not damage chromium plating or grouting. It can be used on all materials resistant to acids: coverings in ceramic, bricks, glass mosaic; bathroom fixtures, glass walls or shower cubicles. Do not use on materials sensitive to acids such as polished marbles and limestone.

USE MODALITY

Ready to use product. Open the valve and spray the product on the surface to be cleaned. Let act for a few minutes. If the residue is very solid, rub with abrasive sponge, otherwise rinse directly with clean water. Repeat if necessary. Lifting the mesh on the head of the sprayer it is possible to apply the product simply by spraying, with reduced formation of foam. Do not apply on materials sensitive to acids.

Indicative consumption: according to the type and consistency of dirt to be removed.
