DEFINITION

Neutral hydro-alcoholic solution with anionic and non-ionic surfactants and synergic agents.

USE AND PERFORMANCES

Concentrated detergent with degreasing action for all kinds of washable surface. Low foaming.

The combined action of surfactants and alcoholic solvents in CB90 makes easier the removal of soil from surface and grouts, without leaving residues.

CB90 is ideal for deep cleaning of polished and lapped Porcelain Tiles. Also suitable for heavy-duty degreasing and recover of dirt and worn surfaces (kitchens, canteens, restaurants, outdoors, ect.) and to remove decayed and altered wax treatments.

Recommended for the removal of residues of tile laying and grouting on surfaces made with acid-sensitive materials (such as polished Marble, Limestone, some kind of Slate, etc.)

Use diluted for the frequent cleaning of floors made with ceramic tiles, vynil, stone, cotto and terracotta bricks, aggregates and concrete tiles. Active ingredients present in its formula guarantee for a non-aggressive cleaning action and allow the surface degreasing without damaging the protective treatment.

CB90 does not leave any cloud or dullness. It is pleasantly scented of lavender. Used diluted (<5%) does not need rinse.

USE MODALITY

Ordinary and frequent maintenance

Use CB90 very diluted up to 2%: add half glass of CB90 in 2-3 litres of water, pour the product on the surface and rub it energetically with a soft cloth / sponge / mop.

Extra-ordinary maintenance or heavy-duty degreasing:

Use CB 90 pure or diluted up to 20-50%; spread the product on the floor, wait for a few seconds, then rub it energetically with a brush, a pad or a floor machine.

Remove liquid and rinse with plenty of clean water.

Indicative consumption: depending on dilution and amount of soiling.
