## DEFINITION

Concentrated water solution of anionic and non-ionic surfactants, complexing agents, water-soluble solvents, organic and inorganic alkalis.

## **DESTINATION AND PERFORMANCE**

**DETERFLASH** is a concentrated alkaline detergent with controlled foaming power, specific for the degreasing of all types of porcelain tiles (polished, natural matt, textured, glazed) and ceramic tiles. Ideal for the extra-ordinary cleaning of surfaces subjected to organic and oily stains, kitchen grime and workshop dirt.

The synergic power of active ingredients utilized in its formula allows to remove effectively the soil linked to micro-porosity. **DETERFLASH** can be used diluted with water, according to the consistency and kind of dirt. Can be used both for manual wash and scrubber-dryer machines.

**DETERFLASH** works well at high concentration for the extra-ordinary cleaning of cotto tiles, bricks, stone, concrete floorings and as wax remover for any washable surface resistant to alkalis.

## DIRECTIONS FOR USE

For the removal of stains: use pure, pour on the floor and let it stand for a few minutes. Rub with a medium-hard abrasive spreading the product on the whole tile / continuous surface.

For extra-ordinary cleaning, dilute with water (max 25%), according to the consistency of dirt.

For the use with scrubber-dryers, dilute at 2-5% max.

Always execute a preliminary test to fix concentration and mode of use.

Consumption: depending on solution and consistency of soil.
